## Important Notes 重要提示

- 1. Please note that in order to be eligible to open a TVC account under the Mandatory Provident Fund Schemes Ordinance, you must be a current holder of a contribution account, a personal account of an MPF scheme or a current member of an Occupational Retirement Scheme (ORSO scheme) who is exempted from the provisions of the Mandatory Provident Fund Schemes Ordinance (Cap. 485) (MPFSO) by virtue of section 5 of the MPFSO (i.e. a member of an MPF Exempted ORSO Scheme).
  - 請注意,在強制性公積金計劃條例下開立可扣稅自願性供款帳戶的資格。您必須為現時擁有某強積金計劃的供款帳戶、個人帳戶或於強制性公積金計劃條例第 (485 章)第 5條規定中所(即獲強積金豁免的職業退休計劃)豁免的職業退休計劃的成員。
- 2. The Mandatory Provident Fund Schemes Authority may verify the eligibility of the TVC account holders. 強制性公積金計劃管理局可能會核實可扣稅自願性供款帳戶持有人資格。
- 3. Please note that if the total amount of TVC made in a year of assessment exceeded the maximum tax deductible limit, the amount exceeded allowance will not be eligible for tax deduction and TVC account (including the amount exceeding the deductible limit as mentioned above) is subject to the same vesting and preservation rules and withdrawal restrictions applicable to MPF mandatory contribution.
