

Fund Commentary 基金評論

Global equities closed 2023 on a strong note, buoyed by the US Federal Reserve (Fed)'s more dovish stance with US policymakers forecasting rate cuts over the coming year. The news reinforced investors' belief that rates were now at their peak and inflation had now been tamed. US bonds rallied over December, building further on November's robust advance, as investors priced in the potential for rate cuts in 2024. The 10-year Treasury bond yield fell around 50 basis points (bps) over the month, moving back below 3.9% for the first time since July.

環球股市在 2023 年強勢收市,受惠於美國聯儲局採取較溫和的立場,美國決策者預 測未來一年將會減息。消息令投資者更加深信利率已見頂,而且通脹亦已受控。繼 11 月份強勁上升後,美國債券在12月份繼續上升,因為投資者消化2024年可能減息的 情況。10年期美國國庫券收益率在月內下跌約50點子,自7月份以來首次跌至3.9 %以下。
