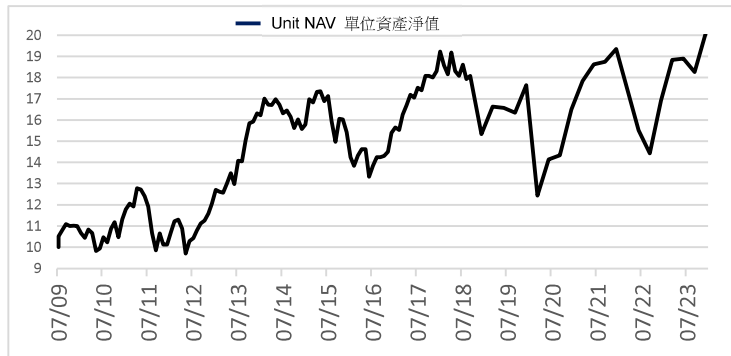

Fund Commentary 基金評論

European equity markets extended gains made in November by remaining in bullish territory during December. They were mainly driven by expectations of rate cuts by central banks in early 2024, with the Fed signalling multiple rate cuts in 2024. Real estate, industrials and materials were the best performing sectors over the month, while energy was the only sector to post negative returns in December as a weakening oil price weighed on the sector. The European Central Bank kept interest rates at 4.0% as expected for the second consecutive meeting. The ECB forecast inflation would continue to decline gradually over 2024, with the Central Bank saying there was still 'work to be done'. However, markets have started to price in a rate cut in the first half of 2024.

歐洲股市在 12 月保持看漲，延續了 11 月的漲幅。主要是受到央行在 2024 年初降息的預期推動，聯儲局暗示將在 2024 年多次降息。房地產、工業和材料是本月表現最好的板塊，而能源是 12 月唯一出現負回報的板塊，因為油價疲軟對該板塊造成壓力。歐洲央行連續第二次會議將利率維持在 4.0%，符合預期。歐洲央行預測通脹將在 2024 年繼續逐步下降，央行表示仍有「工作要做」。然而，市場已開始消化 2024 年上半年降息的影響。
