

Fund Commentary 基金評論

Global equities closed 2023 on a strong note, buoyed by the US Federal Reserve (Fed)'s more dovish stance with US policymakers forecasting rate cuts over the coming year. The news reinforced investors' belief that rates were now at their peak and inflation had now been tamed. At a sector level, real estate stocks surged, with industrials shares also enjoying solid gains. In contrast, the energy sector weakened as oil and natural gas prices weakened. Global bonds extended the rally that started in November. Bond yields moved sharply lower, as inflation came in below expectations.
